- To work closely with and manage the relationship with formal project partnerships and look to expand partnerships, including VCSE (voluntary, community & social enterprise) and private sector partners.

 with a good food movement and their local food economy, increasing awareness of and participation in
 related activity.
- Take the lead on creating an enhanced social media presence, linking with existing partner online platforms.
- Organise a programme of member-led meetings, producer visits, pilot local food markets, talks and workshops.
- Develop online and practical resources, including an interactive online toolkit, newsletter, and social media and marketing support.
- Keep records of all activity undertaken and participant engagement to assist in project evaluation and contribute to the preparation of reports.
- Support MEC and project partners in communicating and disseminating progress and achievements of the projects through a variety of channels, including social media.
- Develop and deliver awareness raising initiatives with a range of stakeholders and partners and run pilot initiatives to achieve the outcomes of the project.
- To work closely with the Middlesbrough Food Partnership and Food Power Alliance in all aspects of planning, coordination and delivery.
- To support the work of the Middlesbrough Food Partnership and Food Power Alliance, and contribute to the 22 Carrot Gold campaign, Middlesbrough plan to achieve Sustainable Food Places Gold Award.
